Candidate Vetting Process

To ensure the sustainability of this program, there will be a vetting process for those interested in attending. It is important that the appropriate people attend this course as they will be asked to provide this training to staff at their agency.

Attendees are required to meet the following criteria:

1. Preferably, be a trainer already; and

2. Understand the importance of de-escalation training and the role it plays in building stronger community relationships.

Agencies are required to do the following:

1. Provide a Letter of Recommendation from the Supervisor/Chief/Sheriff. Please include the specific course, location, and date of the training your officer will attend.

2. Promote support for the project and its importance.

3. Assure the trainer will be given every opportunity to educate staff on the need for and techniques involved in de-escalation within law enforcement.

4. Conduct an in-house training within 90 days of completion of the Instructor course and report the training data (i.e., dates and number of attendees at each training session) required by the funder. A data collection form will be provided to you.
