**Day One** focuses on domestic violence and strangulation-related assaults, covering investigative strategies, medical and forensic findings, and trauma-informed interviewing techniques.



Colleen served as a forensic child interviewer and was part of the Meadowlark House Child Advocacy Center team from 2004 to 2022. She was selected by the Kansas Governor's Office to help develop and deliver domestic violence training for law enforcement and was approved to do so through the Kansas Coalition Against Sexual and Domestic Violence (KCSDV) and its federal grantors. Although the state did not have a formal certification process, her selection and training efforts were officially supported through state-level partnerships and federal grant programs. She also collaborated with agencies such as the Kansas Attorney General's Office, Aequitas, and the FBI Child Abduction Rapid Deployment team.

Colleen has earned multiple awards, including Officer of the Year and the AG's Outstanding Victim Service Award. After retiring from the KBI as a Special Agent in 2025, she continues to serve as an expert witness in domestic violence, strangulation, and child abuse cases. Colleen is currently pursuing a Master's in Clinical Psychology.
